ORDER

The petitioners are the accused in Sessions Case No.588 of 2014. They are charged with having committed the offence under Section 20(b)(ii)(c) and 29 read with 8(c) of Narcotic Drugs and Psychotropic Substance Act, 1985.

2. The allegation is that they were found to be in possession of 30kg of Ganja. The learned counsel submits that the petitioners have been in custody since 10.05.2014 and they may be granted bail.

3. Heard.

4. The quantity of Ganja involved in this case is 30 kg, which is commercial quantity. Final report has already been filed. It is not proper to grant them bail.

The learned Judge will try to dispose of the case without any delay.
