2. Petitioners are alleged to have committed the offences under Sections 143, 147, 341, 353 read with Section 149 of the Indian penal Code.

3. The prosecution case is that they obstructed the revenue officers from discharging their duties when they visited a property in connection with a dispute. The learned Public Prosecutor submits that final report has already been filed. Since investigation is over the petitioners need not apprehend arrest. They may seek for bail in the trial court.
