Petition filed u/s.439 Cr.P.C.

2. Petitioner is alleged to have committed the offences under sections 143, 147, 148, 341, 323, 324, 326, 447 read with sec. 149 IPC. He has been in custody since 27.05.2015. Co-accused have already been granted bail. Further detention of the petitioner is not necessary.

3.Heard.

In the result, this application is allowed.

1) The petitioner will be released on bail on his executing a bond for Rs.25,000/- (Rupees twenty five thousand only)with two solvent sureties each for the like sum to the satisfaction of the learned Magistrate concerned.

2) He shall appear before the investigating officer between 11 a.m and 12 noon on all the 2nd and 4th Tuesdays for three months, or till the final report is filed, whichever is earlier.

3) He shall not threaten or attempt to influence the witnesses, nor shall he destroy or attempt to destroy the evidence
