ORDER

Petition filed under Section 439 Cr.P.C.

2. Petitioner is said to have committed the offences under Sections 307, 323, 326, 341 of the Indian Penal Code, 1860. The prosecution case is that he along with co-accused assaulted the victim with dangerous weapons causing injuries on his head.

3. Heard.

4. The petitioner has been in custody since 19.06.2015. Some of the co-accused have already been granted bail by this Court. Having regard to these facts, I am inclined to grant the prayer of the petitioner.

In the result, this application is allowed.

- 1) The petitioner will be released on bail on his executing a bond for Rs.50,000/- (Rupees fifty thousand only) with two solvent sureties each for the like sum to the satisfaction of the learned Magistrate concerned.*
- 2) The petitioner shall appear before the investigating officer between 10 a.m and 11 a.m. every Thursday for four months, or till the final report is filed, whichever is earlier.*

- 3)He shall surrender his passport before the lower court concerned or if he does not have one, he shall file an affidavit to that effect within five days of his release.*
- 4)He shall not leave India without the previous permission of the court of enquiry or trial court, as the case may be.*
- 5)He shall not intimidate or attempt to influence the witnesses, nor shall he get himself involved in any other criminal case.*

If the petitioner violates any of the above conditions, the court of enquiry/trial is empowered to cancel the bail in accordance with the law.
