Petition filed under Section 439 Cr.P.C.

2. Petitioner was the accused in Crime No.132 of 2012 which was taken on the file of the Sessions Judge as SC No.38 of 2013 he was granted bail. But he absconded and thus forfeited his right. He was arrested on 31.07.2015 pursuant to the non bailable arrest warrant issued by the court concerned. He prays that he may be granted bail.

4. The petitioner had been absconding for about two years. The allegation was that he imported IMFL from Karnataka to Kerala. He has forfeited his right to be on bail. Having regard to this fact and the nature of the offence I am not inclined to grant him bail now.
