JUDGMENT

In a batch of writ petitions, out of which the present contempt cases arise, this Court issued directions to the Kerala Water Authority, which is represented by the Managing Director, to pay the revised pension arrears due to the petitioners, within a period of six weeks from the date of receipt of a copy of the judgment. Initially complaining of non compliance with the directions issued in the judgments, all the petitioners came up with contempt cases. Today, at the bar, the learned counsel for the petitioners has represented that pending the consideration of the contempt cases, the respondent authorities have paid the entire arrears due to the petitioners. He has accordingly requested the Court to close the contempt cases.

2. The learned Standing Counsel has also concurred with the submissions made by the learned counsel for the petitioners.

In the facts and circumstances, having regard to the submission made by the learned counsel for the petitioners, this Court closes the contempt cases, as having not survived for further consideration.
