Heard the learned counsel for the applicant. This contempt application has been filed by the applicant praying for initiating contempt proceedings for violation of the judgment dated 4th of November, 2014 in OP(RC) No.139/2014. Learned counsel for the applicant submits that this Court passed an order directing Ext.P1 Execution Petition and Ext.P3 claim petition to be disposed of expeditiously within a period of three months from the date of receipt of a copy of the judgment.
