This contempt case has been filed alleging non-compliance of the directions issued in the judgment dated 11.4.2014 in W.A.No. 2005 of 2010. The Division Bench, by paragraphs 18 and 19 has issued the said direction.

2. Learned Special Government Pleader has placed before the court an order dated 13.7.2015 issued by the Director of Health Services, Thiruvananthapuram, wherein an order has been issued in compliance with the Division Bench judgment. The State has already filed a Special Leave Petition (C) No.20112 of 2015 against the Division Bench judgment, which is said to be pending. It is also submitted that subject to the judgment of the Apex Court, an order has already been issued in compliance with the Division Bench judgment.
