J U D G M E N T

This contempt case arises out of order passed by this Court on 11.3.2015 in WP(C) No.7694 of 2015. The dispute pertains to the appointment of manager of the aided school. This Court ordered status quo. In the contempt petition, it is alleged that the respondent herein had attempted to take over the management of school on 1.5.2015, therefore, the respondent violated the order of this Court. Apart from the allegation that the respondent attempted to take over management, nothing has been placed before this Court to substantiate the allegation against the respondent. Therefore, leaving open all issues, this Contempt Case (Civil) is closed.
