JUDGMENT

Ashok Bhushan, C.J.

Heard learned counsel for the petitioner and learned Special Government Pleader.

2. This contempt application has been filed against an interim order dated 30.09.2014 passed in W.P.(C) No.3652 of 2013. Learned counsel for the petitioner submits that the order passed by this Court on 30.09.2014 has been violated. He submits that contempt notice was issued by the petitioner, being Annexure A2 to the parties mentioned therein, but no action has been taken for implementing the directions of this Court. Hence contempt proceedings be initiated.

3. We have perused the allegations made in the contempt case, apart from the general allegation that, interim order dated 30.09.2014 has been violated, neither any instance nor any details of violation has been given in the contempt case. The Contempt proceedings cannot be initiated
