JUDGMENT

Ashok Bhushan, CJ.

This is an application praying for taking action for contempt for non compliance of the order dated 25.6.2015 in W.P(C).No.19091 of 2015. In the order we observed that respondents 2 and 3 shall ensure that there is no obstruction created on the factory gate and the willing workers are allowed to go into the factory. Learned counsel for the applicant submits that blockage is there and the workers are unable to enter into the factory.

2. The learned Government Pleader, on instructions, has submitted that 205 workers are on strike and there are only two willing workers, who were engaged in peeling work, who are given police escort to enter the factory premises.

We are of the view that as on date there is no such violation of the judgment so as to initiate any contempt proceedings. The Police authorities are taking steps to act as per the judgment of this Court. The contempt proceedings are dropped and the contempt case is closed.
