J U D G M E N T

The operative portion of the judgment in W.P.(C) No.21222/2013 merely directed that the petitioners in that Writ Petition as also in W.P.(C) No.18646/2012 be treated as having been regularly appointed from the date on which their appointment in the Handloom Weavers Co-operative Society is certified by the Registrar or the Deputy Registrar, under Section 3 of the Kerala Co-operative Societies Act.

2. The petitioners have now filed the above contempt case contending that the direction in W.P.(C) No. 4449/2014 to report the vacancies, has not been complied with.

3. Since there is no such direction in the petitioners' writ petition, there can be no contempt found. Further, it is

also to be noticed that the respondent has filed a counter affidavit, in which it has been clearly stated that all the existing vacancies have been reported. Hence, no contempt lies and the same is dismissed.
