This contempt case has been filed alleging non compliance of the judgment dated 9th June, 2014. A Division Bench of this Court by the aforesaid judgment directed to revise the monetary benefits including terminal benefits due to the respondents in the writ appeal and the writ appeal filed by the State was disposed of.
