This contempt case has been filed alleging non-compliance of the directions in the judgment dated 04/08/2015. In the aforesaid judgment, we have only directed the police to ensure that Exts.P6 and P7 injunction orders dated 31/06/2014 has to be implemented and appropriate police protection be provided to the petitioner in the matter.

2. The present complaint raised by the petitioner in the contempt case is that though the petitioner was put in possession of the premises, by locking the bath room attached to the room the landlord is compelling him to vacate the premises. The rear entry to the building is also locked.

3. The issues now projected were not the subject matter of Exts.P6 and P7, the injunction orders which we have referred to in the judgment. Under such circumstances, we do not think that any contempt is committed by the respondent as alleged by the

petitioner.

Accordingly, we dismiss the contempt case.
