JUDGMENT

When the Contempt Case came up for hearing today, the learned counsel appearing for the petitioner submitted that the direction issued by this Court has been complied with and the petitioner has been transferred to Kozhikode and the third respondent in W.P.(C)No.6041 of 2014 has been transferred to Palakkad subject to the outcome of W.A.No.1307 of 2014 filed by the respondents in the writ petition.
