The contempt case is disposed of directing the electricity board to consider the application for connection submitted by the 2nd respondent, process the same and issue connection within a period of two weeks from today subject to compliance with the procedural formalities by the 2nd respondent. On receipt of connection, the 2nd respondent shall make the sewage treatment plant functional. Till service connection is provided, the generator shall not be removed from the site. It shall be open to the petitioner to approach this Court with a fresh petition if the cause of action survives thereafter.
