O R D E R

The petitioner herein is the defacto complainant in Crime No.66/2015 of the Kuttiady Police Station registered under Sections 143, 147, 148, 452, 323, 427, 354 and 149 IPC. She seeks a direction for effective investigation in the crime. Now, it is submitted by the learned Public Prosecutor that the police has already submitted final report in the crime on 25.02.2015, and that on the said final report the learned Judicial First Class Magistrate Court, Nadapuram has taken cognizance as C.C.No.283/2015.
