ORDER

It seems that the petitioners were absent before the Court below on 27-2-2015 on the date on which CW8 was present for examination. The learned Counsel for the petitioners had filed an application for condoning their absence. As the learned Counsel had to appear before some other court, he had sought for an adjournment for the cross examination of CW8.
