A private complaint was referred to the police under Section 156(3) Cr.P.C., on the basis of which the crime in question was registered. The matter was investigated and the final report has been filed alleging offences punishable under Sections 415, 416, 417, 419, 420, 464, 465 and 468 read with Section 34 IPC. The petitioner is the 1st accused. The matter is presently pending as CC.2875/2011 before the Judicial First Class Magistrate's Court, Irinjalakuda.

2. On hearing either side and the learned Public Prosecutor, I do not find any ground to interfere with the matter at present. It is too premature to hold that the offences alleged cannot be attracted to the petitioner. Let the matter go for trial.
