The petitioners herein are the accused Nos.1 and 2 in Crime No.86/2012 of the Chandera Police Station. They were granted bail by the court below on certain conditions. In compliance with the conditions for bail, they surrendered their passports in court. Their request to release the passport later was disallowed by the trial court. That order is under challenge in this Crl.M.C. The prosecution now stands quashed as per the order in Crl.M.C No.2276/2014.
