O R D E R

The petitioners herein are the accused Nos. 1 to 3 and 6 to 8 in C.C No.556 of 2012 of the Judicial First Class Magistrate Court, Taliparamba. On the apprehension of arrest and remand to judicial custody in execution of a warrant of arrest issued from the trial court they seek orders from this Court under Section 482 of the Code of Criminal Procedure directing the court below to decide on their request for bail on the date of filing itself. It is for the learned Magistrate to decide whether bail could be granted to the petitioners. The petitioners will have to surrender before the trial court and make application for bail. Let appropriate decision regarding bail be taken by the learned Magistrate. However, a direction can be made to consider and dispose of the application for bail on the date of surrender itself.
