The petitioner herein seeks orders quashing the F.I.R and further proceedings in Crime No.202 of 2013 of Pookottumpadam Police Station of Malappuram District registered under Section 409 of Indian Penal Code. The petitioner is a school teacher. As reported by the court, the Sub Inspector of Police, Pookottumpadam Police Station submitted a report regarding the present stage of the case. It is now reported that, on investigation the Police could find that allegations against the petitioner herein happened to be made on some misapprehension that she has not in fact caused any loss to the school or any other authority, and that further action against her stands dropped.
