ORDER

The petitioner, who is the accused in S.C. No. 215/2014 on the file of the Additional District and Sessions Court -V, Palakkad, has filed this Criminal Miscellaneous Case seeking an order directing the court below to dispose of the aforesaid case within a stipulated period. By order dated 10.04.2015, this Court called for a report from the Presiding Officer regarding the total pendency of the cases, the present stage of S.C. No. 215/2014 and also the time reasonably required to dispose of the same.

2. Now, the Presiding Officer has forwarded a report dated 18.04.2015 to the Registrar, Subordinate Judiciary stating that atleast three months time is required for disposal of the case after framing of charge. A statement regarding pendency of cases before that court is also enclosed along with the letter.

3. I heard the arguments of the learned counsel for the petitioner and also the learned Public Prosecutor appearing for the respondent.

Considering the facts and circumstances of the case, this Criminal Miscellaneous Case is disposed of directing the court below to dispose of S.C. No. 215/2014, as expeditiously as possible, at any rate, within a period of three months after framing of charge.
