What is under challenge is a discharge order, having the effect of concluding the trial process as against the accused Nos. 3 to 6 in the trial court. The learned counsel for the petitioner seeks permission to withdraw the proceeding, with liberty to file revision petition against the impugned order. In view of the delay from the date of order, the petitioner will have to make appropriate application for condonation of delay before the revisional court.

The submission is recorded. Accordingly, this Crl.M.C. is dismissed as withdrawn, without prejudice to the right of the petitioner to file appropriate revision against the impugned order, subject to the question of limitation.
