ORDER

Petition filed under Sec.482 Cr.P.C.

2. Petitioners are accused in C.C. No.722 of 2014 on the file of the Judicial First Class Magistrate Court, Kunnamangalam. The only prayer is to direct the learned Magistrate to dispose of the case immediately.
