ORDER

Petition filed under Section 482 Cr.P.C.

2. Petitioners are accused in CC.NO.1310/2014 of Judicial First Class Magistrate Court-III, North Paravur. They alleged to have committed the offences under Sections 323 and 324 of Indian Penal Code. It is submitted that the matter has been settled and the proceedings in the criminal case may be quashed.

3. Heard the learned counsel for the Petitioners and the respondents 2 and 3 and the learned Public Prosecutor.
