The prayers in this Crl.M.C are as follows:

“i. Direct the Judicial Magistrate of I Class, Varkala to consider and dispose C.M.P No.3243/2014 in Crime No.45/14 as expeditiously as possible at any rate within a time frame fixed by this Court.

ii. Issue such other further reliefs as are necessary in the interest of justice.”

2. In compliance with the orders of this Court, the Judicial First Class Magistrate Court I, Varkala has submitted a report dated 31.07.2015 to the Registry of this Court, wherein it is inter alia stated that C.M.P No. 3243/14 will be disposed of within a shortest possible time, after hearing the parties.
