ORDER

Petitioners are the accused in C.C. No.333 of 2015 of the Judicial First Class Magistrate's Court, Nilambur, which has arisen from Crime No.55 of 2015 of the Vazhikkadavu Police Station, registered for the offences punishable under Sections 143, 147, 148, 341, 323, 324 and 506(i) IPC read with Section 149 IPC.

2. The matter has been amicably settled between the petitioners and the defacto complainant and the other injured, who are respondents 2 to 4 herein.
