ORDER

Petitioners are accused in C.C. No.712 of 2013 of the Judicial First Class Magistrate's Court-I, Perinthalmanna, which has arisen from Crime No.1121 of 2013 of the Perinthalmanna Police Station, Malappuram, registered for the offences punishable under Sections 143, 147, 341 and 323 read with Section 149 IPC.

2. The matter has been amicably settled between the petitioners and the defacto complainant, who is the 2nd respondent herein and the other injured, who is the 3rd respondent herein. The defacto complainant and the other injured have filed Annexure-A2 and Annexure-A3 affidavits affirming that the matter has been amicably settled between them and the petitioners and they have no complaints against the petitioners.

3. No criminal antecedents have been reported against the petitioners. When the matter has been amicably settled, no purpose would be served in proceeding with the matter further, and therefore, all further proceedings in C.C.
