2. Heard learned counsel for the petitioners and learned counsel for the respondent.

3. According to the learned counsel for the petitioners, the court below has not properly considered the question whether the respondent could be permitted to continue the proceedings as an indigent person.

4. *Per contra*, the learned counsel for the respondent has pointed out that the court below has considered all the matters and even the government has no

complaint as against the permission granted by the court below.
