This is a report submitted by the Deputy Director of Local Fund Audit, Cochin Devaswom Audit, Thrissur, after conducting an audit of the accounts of Ratholsavam at Lankeswaram Siva Temple, Chittur, Palakkad District in the year 2012-2013 as directed by this Court in the order passed on 8.10.2003 in O.P.No.39127 of 2001. The report was forwarded to the Honourable Ombudsman pursuant to the order passed by this Court on 3.7.2013. The Honourable Ombudsman thereafter issued notice to the parties and conducted a hearing on 16.7.2013.
