JUDGMENT

This appeal is filed against the order of the Sub Court, Kasargode in E.A.No.69 of 2012 in E.P.No.88 of 2008 in O.S.No.103 of 2006. By order dated 29.6.2015, the case was referred for mediation at the District Mediation Centre, Kasargode. Accordingly the dispute was mediated and the parties have entered into an agreement dated 19.9.2015 settling the entire dispute between them.
