ORDER

This Criminal Revision Petition is preferred against the judgment in Crl.Appeal No.273/2007 of Sessions Court, Pathanamthitta. The revision petitioner was convicted for the offence punishable u/s.138 of the Negotiable Instruments Act and sentenced to undergo imprisonment for a day, till rising of the Court and directed to pay compensation of ₹50,000/- u/s.357(3) Cr.P.C., in default to undergo simple imprisonment for three months.

2. After filing this revision petition, this Court ordered notice on 23.12.2008 to the 1st respondent. But, no

steps were taken by the revision petitioner till date. In such circumstances, this revision petition is dismissed for non-prosecution.
