JUDGMENT

This original petition has been filed for a direction to the respondents 2 and 3 not to interfere with the petitioner's peaceful use of the pathway passing through the property of the fourth respondent and for other reliefs. It appears that the dispute involved in this original petition is essentially a civil dispute between the petitioner and the contesting respondents. The original petition itself shows that there were civil disputes pending before the civil court.
