**J U D G M E N T**

**P.R. Ramachandra Menon, J.**

The learned Government Pleader submits that the judgment and decree dated 31.03.2003 passed by the Sub Court, Mavelikkara in L.A.R.No.72 of 1999, (which forms the subject matter of this appeal), was sought to be challenged by the requisitioning authority as well by way of L.A.A. 1502 OF 2007. After hearing, the said matter has been disposed of as per judgment dated 21.12.2011 (to which one of us was also a member), whereby the extent of enhancement awarded by the Reference Court has been reduced re-fixing the land value as Rs.6117/- per Are in respect of wet land and Rs.7215/- per Are in respect of dry land. In the said circumstance, the learned Government Pleader submits that the present appeal is no more
