JUDGMENT

V.K.Mohanana,J.

The mother of minor child 'Anusha' preferred the above appeal challenging judgment dated 20.08.2014 in O.P. (G&W)No.956/2013 of the Family Court, Kottayam at Ettumanur, by which the respondent herein is appointed as the guardian of the minor child, Anusha and also issued certain directions regarding the custody of the child.
