JUDGMENT

The limited prayer in this petition is for a direction to the Appellate Authority (Land Reforms), Alappuzha to take up Ext.P1 appeal and Ext.P2 petition to condone the delay in filing the appeal and dispose them of on merits as expeditiously as possible.

2. Learned counsel for the petitioners has pointed out that the appeal and the delay condonation petition were filed in 2010 and till date nothing has transpired in the matter. He points out that it causes considerable loss and injury to the petitioners and therefore the petitioners seek an expeditious disposal of the matter.

3. In the light of the order that is proposed to be passed in this petition, it is felt that notice to the respondents is not necessary.

In the result, this petition is disposed of directing the Appellate Authority (Land Reforms), Alappuzha to take up A.A. No. 17 of 2010 and also the petition to condone the delay in filing the appeal and pass orders thereon on merits as expeditiously as possible, at any rate, within a period of three months from the date of receipt of a copy of this judgment.
