J U D G M E N T

This original petition under Article 227 of the Constitution of India is filed seeking a direction to the Munsiff Court, Cherthala to take up O.S.No.62/2013 pending before it and dispose of it as expeditiously as possible.

2. The suit is one for fixation of boundary as well as injunction. Issues have not yet been raised.

3. This Court is given to understand that no commission report is available. Under these circumstances, it becomes difficult for this Court to direct disposal of the suit immediately.

This original petition is disposed of directing the Munsiff Court, Cherthala to take such steps as are necessary for the progress of the suit and after the steps are completed, dispose of the suit in accordance with law within a period of six months thereafter.
