J U D G M E N T

In this original petition, the limited prayer is for a direction to Sub Court, Paravur to dispose of I.A.No. 2588/2012 in O.S.No.141/2011.

2. The petitioner is the first defendant in the suit. The suit was one for declaration of title, possession and injunction of the plaint schedule property. The plaintiff in the suit filed I.A.No. 862/2011 for locating the lie and nature of the property.

3. The present grievance of the petitioner is that I.A.No.2588/2012 has been kept pending and that causes considerable loss and injury to the petitioner.

4. In the light of the order that is proposed to be passed, it is felt that notice to the respondents is unnecessary.
