JUDGMENT

The limited prayer in this Original Petition is for a direction to Munsiff's Court, Manjeri to dispose of O.S. 20 of 2015 in accordance with law.

2. The suit is one relating to election to Malappuram District Volley Ball Association for the period 2013-2017 held on 9.4.2013. The petitioner points out that the matter is urgent and the delay in disposal of the suit will affect his rights.

3. However, this Court is informed that written statement is yet to be filed and the grievance of the petitioner is that on several occasions the suit came up for consideration, and it has been adjourned for a long period.
