J U D G M E N T

An application for getting the attachment lifted is filed by the petitioner by way of I.A.No.1727 of 2015 in O.S.No.512 of 2012 before the Munsiff's Court, Alappuzha. It seems that the said IA is dated 26.05.2015. The complaint of the petitioner is that the learned Munsiff, in disregard of the necessity forwarded by the petitioner, has not taken up the matter and has posted the matter to 15.07.2015.
