J U D G M E N T

The petitioner's husband is the plaintiff in OS No. 385/2009 on the file of the Munsiff's Court, Muvattupuzha and the respondents 1 to 6 are the plaintiffs in O.S.No.493/2011 of the same court. The petitioner seeks for an early disposal of the above suits.

2. This Court is called for a report from the court below with regard to the possible time within which the matter can be disposed of. It appears that the delay is on account of non filing of the commission report by the Advocate Commissioner. It is stated in the report by the learned Munsiff that six months' time is required to dispose the two suits.

3. In view of the facts and circumstances, the learned Munsiff is directed to dispose the suits on or before 31-03-2016.
