JUDGMENT

Thottathil B. Radhakrishnan, J.

We have heard the learned counsel for the petitioners quite in extenso. We have also heard the learned Assistant Solicitor General.

2. The impugned Ext.P3 is only an interlocutory order passed by the Tribunal, that too, to some extent, in favour of the first two applicants. The Tribunal will obviously consider the main matter, particularly regarding the issue raised by the applicants, on the creation of the Multi Tasking Staff in terms of the revised charter of duties. We think that no further interlocutory relief could have been granted by the Tribunal. We see no legal infirmity or jurisdictional error in the impugned interlocutory order warranting visitation at our hands in exercise of authority under Article 227 of the Constitution of India. Hence, leaving open all issues in the original application before the Tribunal, this original petition is dismissed.
