The issue involved in this case is exactly similar to the issue dealt with by this Court in O.P.(CAT) No. 90 of 2015 wherein interference was declined and the O.P.(CAT) was dismissed, granting further period of 'two months' to comply with the direction given by the Tribunal as per Ext.P7 order.
