J U D G M E N T

In this original petition, the prayer of the petitioner is essentially for a direction to the Debt Recovery Tribunal [DRT], Ernakulam, to consider and pass final orders in Appeal 15/2014, pending before the said Tribunal, expeditiously, after hearing him.

When the matter came up for admission, I had called for a report from the Presiding Officer, DRT, Ernakulam, as to the time required to pass orders in the aforesaid Appeal.
