The O.P(DRT) is filed seeking a direction to the Debt Recovery Tribunal, Ernakulam, to consider and pass final orders in O.A.No.47 of 2014 expeditiously after hearing the petitioner. When the O.P(DRT) came up for admission, I had called for a report from the Presiding Officer, Debt Recovery Tribunal as regards the time required for passing final orders in the said O.A. By a report dated 16.11.2015, the Debt Recovery Tribunal has indicated that it would require six months time to dispose the O.A.
