The O.P(DRT) is filed seeking a direction to the Debt Recovery Tribunal, Ernakulam, to consider and pass final orders in S.A.No.301 of 2015 expeditiously after hearing the petitioner. When the O.P(DRT) came up for admission, I had called for a report from the Presiding Officer, Debt Recovery Tribunal as regards the time required for passing final orders in the said S.A. By a report dated 13.11.2015, the Debt Recovery Tribunal has indicated that it would require six months time to dispose the S.A. Taking note of the said report, I dispose the O.P(DRT) by directing the Debt Recovery Tribunal, Ernakulam, to pass final orders in S.A.No.301 of 2015 on or before 30.04.2016, after hearing the petitioner.
