J U D G M E N T

ANTONY DOMINIC, J.:

The prayer in this O.P. is to direct the Family Court, Thiruvananthapuram, to expedite disposal of O.P.No.1492/2014. On the filing of this O.P., this Court called for a report from the Family Court and accordingly, a report dated 28.3.2015 has been received. Reading of the report does not persuade us to think that the Family Court is guilty of any laches justifying an order as prayed for.
