This petition is filed by the respondent in OP.No.96/2012 on the file of the Family court, Thalassery, seeking a direction to dispose of Ext.P5 petition invoking the supervisory jurisdiction vested under Article 227 of the Constitution of India. The grievance of the petitioner was that though she filed Ext. P5 petition before the Family Court, the Family court was not passing any orders. Though notice was sent to the respondent it was returned unclaimed and this court has declared that service as complete.
