JUDGMENT

Antony Dominic, J.

This appeal is filed by the defendants in O.S.No.1154/04 on the file of the Additional Sub Court, Thrissur, who are aggrieved by the judgment and decree dated 4.1.2013. By order dated 25th November, 2015 the parties were referred for mediation.
